# Addressing the Learning Gap through Social and Emotional Learning

teachers. administrators. Students, supervisors and staff heading back to school this year are dealing with a multitude of significant issues. The stress that the Coronavirus has put on the world, country, community, families and schools in particular is reflected in many ways. After more than a year of home and hybrid learning, where the inequities of the educational systems across the country have surfaced, many students are starting off the school year with a loss of academic and social and emotional learning. Closing the learning gap is major concern of teachers and administrators. The Horace Mann study conducted in March of 2021 found that:

When compared to the previous year, 97% of teachers reported loss of learning.

Fifty seven percent of teachers stated that their students were behind three months in their social and emotional learning.

Forty seven percent of teachers reported a wider performance gap between academically lower and higher achieving students.

During the course of the pandemic, students have had to deal with family issues at home: the loss of jobs and financial security, the loss of a loved one, lack of socialization with classmates and friends, not having the proper tools such as computers and other devices that connect to the Internet and poor Internet connectivity just to name a few. Administrators, teachers and school systems in general now have to address the stresses, the performance gap and the social and emotional needs of students as the school year begins.


Neuroscience research confirms that when students are stressed they find it more difficult to concentrate and focus on the task at hand. Learning is negatively affected. The same could be said for adults and their performance in the workplace.

To address these concerns, many school systems have implemented Social and Emotional Learning programs (SEL).

What is Social and Emotional Learning? Bennett defines Social Emotional Learning

The process through which children and adults acquire and effectively apply the knowledge, attitudes, and skill necessary to understand and manage emotions. set and achieve positive goals, feel and show empathy for others, establish and maintain positive

relationships, and make responsible decisions.

There are five basic competencies in developing Social Emotional Learning and under each of them are subcompetencies. The five basic areas are:

Self-Awareness, Self-Management, Social Awareness, Responsible Decision-Making and Relationship skills

Educators that are trained in SEL can help students address their concerns, anxieties, relationships and feelings about self as they enter school feeling the stresses of the present day environment. There are a multitude of strategies that teachers integrate into their daily activities. For example on an elementary level, teachers can start off their day with a Two Word Check activity asking students to describe how they feel. Students can complete a feeling wheel. Teachers can implement the Count Me Down strategy: share three unique aspects of their family, identify two challenges they are facing or a goal or dream that they have. Educators that are trained in SEL have access to many activities dealing with all of the competencies at each level. Addressing students' social and emotional needs, being empathetic and understanding where they are coming from helps improve academic performance. In today's environment, we all should be knowledgeable and trained in the Social and Emotional Intelligence Competencies.

# **Informational Updates**

Hello everyone! Hope all is well...By now many of you are aware that these two introductory sentences are the opening greetings to yet another of my Informational Updates. What I try to accomplish in these updates is to clarify and inform you of the myriad medical benefits that you are entitled to. Sometimes, I will include tips on avoiding scams and protecting your identity,

To ensure that you receive or continue to receive the Informational Update, notify me ASAP if you have had a change in your e-mail address, or you have never submitted to me your email address (e.g., new members).

# **Prior Authorization Under the NYC Medicare Advantage Plus Plan: What is it About?**

Under MAPP there are certain medical treatments that your network provider must get prior authorization from MAPP before you receive the care or service, e.g., intensive outpatient therapy.

MAPP will generally grant prior approval for a treatment if 1) it is deemed a "medical necessity," i.e. the services, supplies, or drugs are "needed for the prevention, diagnosis, or treatment of your medical condition and meet accepted *standards* of medical necessity," and 2) and it is covered by the plan.

If you are using an in-network doctor and prior authorization is needed for a treatment, you are not responsible for requesting it; that is the responsibility of your provider. If your provider doesn't ask for the prior authorization, he or she CANNOT bill you for the treatment.

While in-network providers are required to get prior authorization, out-of-network doctors are not. However, if the treatment requires prior authorization, you should encourage the provider to ask for it before you receive the service. If he or she does not, then MAPP will review the claim after you have received the treatment, and:

If MAPP approves the claim, they will process it according to the rules of the plan.

If MAPP disapproves the claim, i.e., the treatment was deemed not medically necessary, it will be denied and you will be responsible for payment.

To summarize, if a procedure requires prior authorization and your provider is an in-network doctor, it is the provider's responsibility to ask for prior authorization, not yours. If the provider is out-of-network, then you should ask him or her to seek prior authorization.

Whether you see an in-network or out-of-network provider, if your provider asks for prior authorization and it is denied, MAPP will notify you. If you wish to continue with the treatment, you will be responsible for the cost. MAPP will also inform you that you have the right to appeal the decision.

(As of this writing, a temporary restraining order has been issued extending the Oct 31 deadline for opting out. Under the order, the City and the Alliance must present a revised plan for contacting providers, and for establishing a new opt-out date. The judge who is hearing the case will determine whether the revised plan resolves the deficiencies of MAPP that caused him to issue the restraining order.)

# AFL-CIO, AFSA, CSA, ARA TRENDS... Continuing 20 years of cooperation

There have been several new developments in national and local representation of retirees over the past few months, and the ARA and AFL-CIO and AFSA have been involved. I'd like to share with you some of these developments and how to keep up-to-date.

First, let me note that thanks to AFSA (AFL-CIO), all of its locals across the country became members of the ALLIANCE FOR RETIRED AMERICANS (ARA) when it was formed in May 2001.

The ARA is a non-partisan organization of retired trade union members affiliated with the AFL-CIO, as well as non-union, community based members, and has advocated for the health and economic security of retirees and senior citizens since 2001. It represents over 4 million members and has active chapters in 39 states today.

Ernie Logan, AFSA's President and a Vice-President of the AFL-CIO is actively involved with representing our interests at the highest levels of our nation, and is working closely with Liz Shuler, the President of the AFL-CIO and the national ARA to insure that result. (He and I have had conversations as well.)

In addition to this national representation, CSA members are represented at the state and local AFL -CIO levels as well. For example CSA retirees are active at the NYC Central Labor Council, as well as the Florida Alliance for Retired Americans (FLARA). We are hoping to duplicate this relationship with CSA Retiree Chapters and other state ARA chapters, as we prepare for next year's elections across the country.

With that as a background, let's look at the current issues facing us as retired union members. I'll list some sources for updates and follow-ups at the end of this column.

## WE ARE ALL ESSENTIAL WORKERS

This year, we remembered the 20<sup>th</sup> anniversary of 9/11. Do you remember where you were that day? That day, we became essential workers!

Like many of you, I was at school. I saw the Towers collapse. Almost immediately, there were literally hundreds of parents, grandparents, older brothers, aunts and uncles waiting outside to take their children home. We organized the school to quickly and efficiently have the children signed out. Our phone banks were inundated with parents calling to find out if their children were safe. The cafeteria workers made extra food, staff stayed late, and finally, by 9 pm, the last student was picked up. In the next three days, we learned that two students had lost a parent. We monitored all of the family concerns, provided counseling, and set up a fund to purchase food to send home. We immediately began group and individual support programs for our students. I am sure that you had similar situations in your school, and that you stepped up to become an essential worker at that time.

Now, moving forward from September 11, 2001, to 20 months ago, the Covid-19 pandemic exploded, and the current active teaching and supervisory staff stepped up to become essential workers. The safety of the children under their care is well documented. From zoom lessons, to setting up and reconfiguring classrooms, cafeterias and gyms, new procedures were quickly and efficiently instituted. Of course, this varied from state to state. In New York City 99% of supervisors are vaccinated. Only 12 principals are not vaccinated. Teachers have a 97% vaccination rate. Masks are mandated in all New York State schools, on buses and at indoor activities. We are proud of the essential education personnel.

In Florida, of course, we have a different situation. We actually have government agencies interfering with the educators trying to provide a safe environment for the children under their care. The new war against our democracy is now being fought at school board meetings and mask wearing is leading to actual physical fighting. This war has been enhanced by the Governor, mandating what teachers can and cannot teach their students. History and science teachers in particular are under strict guidance to teach both sides, even the non-

scientific side. What is the other side to teaching about the Holocaust?

As retirees, what part do we now have to play? The answer is that we must become essential workers to continue our heritage of providing a quality fact based public educational system. We need to become active. Learn about the people running for the school board. What is their stand on curriculum and fact based education? Get involved in current events groups and webinars, so you can have a civilized discussion with your peers. Talk to your children and your grandchildren about the current political situation in our country. Make sure that you sign up for an absentee ballot, and make sure to vote in all national, local, and school board elections. Most importantly, remember our proud heritage of being essential workers! We can still influence others to behave in a civil way, and to talk to each other, and not at each other.

CSA is doing everything it can to get information about what is happening in various states. Participate in our local chapter activities. There are many wonderful programs. Central CSA has many free programs on its website. Become involved. **Retirees can still be essential workers!**

VOTING IN THIS YEAR'S ELECTIONS: Although this is considered an "off-year election year," there are local and state elections from Mayors, Governors, State Legislators, to School Boards etc. to be contested, and special elections for US Congress Representation and ballot questions. Remember, Public Education is primarily a local function;

VOTING RIGHTS...includes the Freedom to Vote Act which would make Election Day a federal holiday, establish same day voter registration nationwide, set federal standards on mail-in voting, establish limited voter ID requirements and ban partisan gerrymandering;

COVID VACCINATIONS...only 15% of people, age 65 and older have received the booster vaccine, as of October 20<sup>th</sup>;

SUPPORT FOR UNION MEMBERS ON STRIKE ....ON October 5<sup>th</sup>, 1,400 workers at four Kellogg Co. plants in Michigan, Nebraska, Pennsylvania and Tennessee went on strike against the company; send a letter of support to the AFL-CIO:

PASS THE PRO ACT: Which would be the most significant worker empowerment legislation since the Great Depression, in that it would empower workers to form unions and bargain over wages and work conditions, hold corporations accountable for union-busting, and would repeal "right to work" laws; send a letter of support to the AFL-CIO.

PRICE OF PRESCRIPTION DRUGS...the National and Florida ARA leadership have asked that we write to our Congress members to support Medicare negotiating directly with pharmaceutical corporations to lower prices;

These are but a few to the many issues on which the ARA, the AFL-CIO, and AFSA have joined.


